



Inspection Report

1st Youth and 8th European Deaf Badminton Championships 2018

Trencin, Slovakia, 24 June 2017.

Deaflympics Committee of Slovakia submitted an application to host 1st Youth and 8th European Deaf Badminton Championships on 21 to 29 July 2018 in Trencin, Slovakia.

EDSO representative Martin Bogard (Badminton TD).

Location: Trencin

Population: Approx 60,000

Distances from the European cities:

- Bratislava – 120km
- Wein – 205km
- Brno – 130km
- Budapest – 260km

International airport: Bratislava. The OC will arrange the transport to Trencin.

Currency: Euro

Former European Deaf Championships: No

The Badminton m-sport Hall is a quite short distance from three hotels and it has excellent facilities with indoor and outdoor up to 250 seats for the meals.

It has 12 badminton courts but we will use 5 courts with 300 seats for the athletes, officials and spectators. It also has a separate badminton hall for training purpose.

Doping room: Yes.

Hearing test: Yes, at Trencin ENTclinic with the latest technology.

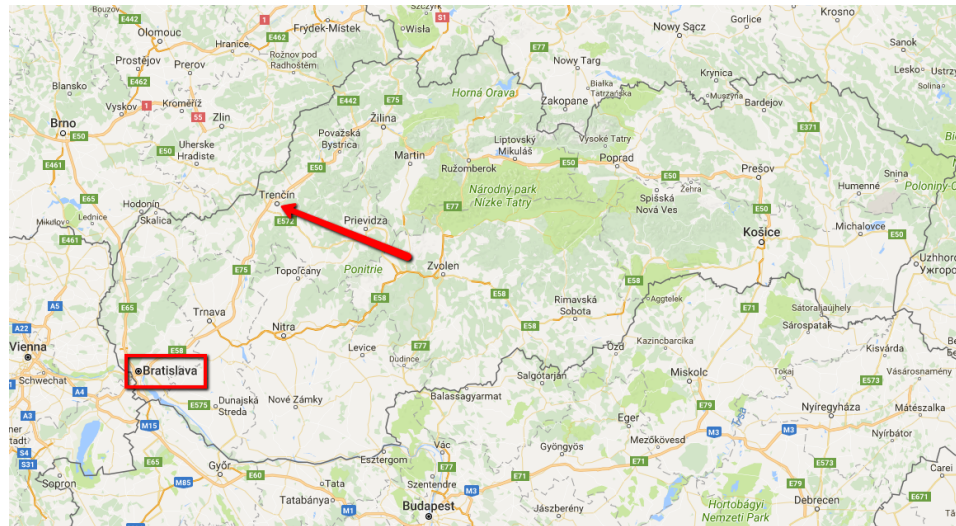

Dear Mr. Dědeček


On June 24, 2017, we will not be able to attend the second inspection day of MENB in Trenčín. However, we are interested in attending a possible further meeting and agreeing on the course and scope of the inspection, once the number and types of sampling, the types of analyzes and the collection days are known.

The Anti-Doping Agency of the Slovak Republic meets the ISO 9001: 2015 standard with its requirements and is almost certainly ready to carry out the required doping control to the extent that the European Federation of Deaf Athletes will require.

For the performance of doping control we provide standard:

- Doping control doping control officers (DCO),
- material required for Berlinger
- sampling, safe transport of samples from the venue to the laboratory (on multidisciplinary events and in cooperation with the organizer of the event),
- mediation of analysis at WADA by an accredited Seibersdorfe laboratory Austria.
